Agenda Item 3: Action and Grant Items

a. Action items

- Annual-17 Online Child Safe Sport Training now completed by all Committee members.
- **02/24 Club facilities improvements** Terry Caldwell reported that he has been liaising with Andrew Kaye and we will not be ready to submit an application to AlburyCity for the whole project in the current round of funding. Instead it is hoped that an application for the changerooms/storage areas stage (at the side of the existing playing area) will be ready to submit by the end of November, with the Clubrooms/kitchen/office stage (existing area across the front of the playing area) to be applied for in a future round.
- 03/24 Insulation of playing area pending availability of a grant.
- 12/24 Asbestos warning labels still to be undertaken by third party (via AlburyCity).
- 15/24 Christmas Lunch 2024 arrangements list available in the Clubroom for members to register their interest. Numbers to be finalised by the end of November.
- 17/24 AWTTA Veterans Tournament (23 & 24 November) registrations currently around 60, with entries closing tonight. 2025 Fees

Agenda Item 7: General Business

Update to By-Laws

lan Radley spoke to the proposed update to include additional By-Laws to provide guidelines when fill-in players are required when all teams are playing in finals for a Division.

MOTION: That the following By-Laws be added to Section 8.2: Finals' Pennant Matches

8.2.3 Fill-in Players when all teams are playing in Division 1, 2 or 3 finals

- 8.2.3.1 The Coordinator is responsible for organising fill-ins as per these guidelines.
- 8.2.3.2 Fill-in players should be chosen from players that have filled in within the current season.
- 8.2.3.3 The fill-in player, where possible, shall be of the same AWTTA ranking. i.e. Number 1 player, Number 2 player etc and shall be the next lower ranked player as per Ratings Central points.



- 8.2.3.4 In the event that no lower ranked player is available from the current season a Number 1 player with a maximin 70 Ratings Central points more, a Number 2 player with 50 points more or a Number 3 player with 30 points more can be used. Only one (1) player above points is allowed per team.
- 8.2.3.5 If a fill-in player for a Number 1 player with higher Ratings Central points is used, they cannot play both doubles.
- 8.2.3.6 If a fill-in player cannot be found from the current season the Coordinator may use a player from the Division below if within 50 points of the replacement player or a player that has filled-in within the last two seasons, using Ratings Central points for replacement reference.

8.2.4 Fill-in Players when all teams are playing in Division finals for Division 4

8.2.4.1 Coordinator is responsible for organising fill-ins with the best interest of fairness for the competition, taking into consideration the above guidelines.
